Section 33(1) of the *Municipal Elections Act, 1996* provides that a person may be nominated for an office by filing a nomination form in the Clerk's Office in person or by an agent. The nomination shall be in the prescribed Form 1 (Nomination Paper), signed by the person being nominated (facsimile signatures are not acceptable) and be accompanied by the prescribed nomination filing fee of \$200 for the office of Mayor or \$100 for all other offices listed herein. The filing fee may be paid only in cash, by debit card (where available), certified cheque or money order made payable to the municipality.

The nomination may be filed with the Clerk during normal office hours from May 2, 2022 to August 18, 2022 and on August 19, 2022, being Nomination Day, between 9:00 a.m. and 2:00 p.m. for the following offices:
